**Registration in the Land Survey Council (LSC)**

All Officers of the Sri Lanka Surveyor's Service who possess the qualifications referred to in Section 39 and 40 of the Survey Act No: 17 of 2002 are required to register in the Land Survey Council (LSC)

2. Therefore you are requested to make your application with the following documents to the Secretary, Land Survey Council through the **Surveyor General (Survey Service Unit), P.O. Box 506, S.G.O., Colombo 5**. A specimen Application Form is annexed. Please furnish all particulars required in this form in order to determine your registration number by the LSC.

- a) A certified copy of your National Identity Card (both sides). This could be certified by Senior Officer in the Survey Department who is not below the rank of Snr.SS / Secretary or Member of Land Survey council. In addition to the officers mentioned, a JP could also certify.

Your full name should tally with that of your National Identity Card. If you are using different name you have to submit a certified photo copy of your fresh National Identity Card (both sides). For this purpose an affidavit signed by a Justice of Peace is not accepted

- b) All your professional certificates should be certified by issuing Authority. Alternatively, you could get them certified by **Senior Officer in the Survey Department who is not below the rank of Snr.SS / Secretary or Member of Land Survey council** by submitting the originals to them. In addition to the officers mentioned, a JP could also certify.
- c) Registration fee has to be paid as stipulated in the Survey Act No. 17 of 2002, Section 39-(3). The Registration fee could be paid at any branch of the Bank of Ceylon in favour of "Chairman, Land Survey Council" Account No 0001658239 – Bank of Ceylon, Narahenpita branch and attach the credit slip to application.
